# New Interactive Bike Rack Map

Commuter Services launched its new, interactive Regional Bike Rack Map! The electronic map provides bicyclists with information and locations of more than 120 bike racks throughout the Commuter Services nine-county region.

Bicyclists can quickly obtain directions and view photos and site descriptions of each rack, making it easier to find parking while they commute through the area. The map is an ongoing project and will continue to grow with more bike rack locations being added during additional phases of the project. # Inaugural Vanpool Appreciation Month Celebrated

Commuter Services of Pennsylvania recently completed its inaugural Vanpool Appreciation Month. Vanpool riders were encouraged to share how vanpooling has impacted their daily commute. The entries were judged and three vanpools were selected as winners. A typical vanpool consists of eight to 15 riders who have a consistent work schedule and ride more than 20 miles one way to work. Currently, Commuter Services assists 35 vanpools in a nine county service area.



More than 240,000 miles one-way are eliminated each day by these commuters choosing vanpooling as their commute option rather than driving alone.

By participating in a vanpool, commuters save money on gas, insurance and wear and tear on their personal vehicle.

Commuter Services works with employers and commuters to encourage a variety of commuting options including biking, taking transit, carpooling, walking, vanpooling or telecommuting. Using alternative transportation results in fewer cars on the roadways, improved air quality and reduced traffic congestion and travel time.

## Earth Day Challenge



Commuter Services of Pennsylvania issued its annual challenge to commuters to try an alternative commuting option, other than driving alone, during Earth Week, April 20th - 26th. In total, 336 commuters logged 69,115 miles by taking alternative transportation during the week of Earth Day. A winner was chosen from each of the nine counties who participated. William Brent (right) of Dover, York County, logged 132 miles during Earth Week and was also the randomly selected grand prize winner.

## Bike to Work Week Challenge

A total of 112 participants logged 3,459 miles while commuting to work by bicycle during this year's annual Bike to Work Week Challenge. Phoenix Contact took first place as the employer with the most participation; seven employees participated in the event, logging a total of 197 miles commuted by bike. Chris Weaver of Dauphin County, who rode 30 miles to his job at Penn State Harrisburg, was the randomly selected grand prize winner.




