Early in 2014 the Commuter Services staff opened a conversation about the possibility for regional bike sharing. Since that time, several communities such as Lancaster and Harrisburg have continued on the path to developing the first bike share programs in the region. Beyond bike sharing, 2014 also provided the time frame for Commuter Services to release the first phase of our bike rack map. This online listing of bike racks throughout the service area

enables cyclists to identify convenient places to securely park their bikes while traveling through south central PA.

The latter half of 2014 saw the final pieces of the Best Workplaces for Commuters program begin to come together. We anticipate the first BWC awards banquet in Spring 2015. Late in 2014, two of our partner transit agencies, BARTA in Berks County and RRTA in Lancaster, put their respective organizations under one management umbrella and formed the South Central Transit Authority.

The near future will bring refreshing new opportunities for the Commuter Services program in four more counties to the north of our existing service area. As we embark on the introduction of our services to a new region, we look forward to the formation of new friendships, additional community partners, waves of fresh commuters saving money, and most importantly—less traffic congestion and better air quality.

Before fully letting go of the 2014 year I would like to join the entire SRTP Board of Directors in taking a moment to thank Beth Artman for her service to the SRTP. Beth became Chair of the SRTP just as I came into the organization in January 2013. 

# A PLANNED VISION

## Our Strategic Plan

The close of the 2014 calendar year brings with it the completion of the first 10 years of the Commuter Services of Pennsylvania program. The success of the first 10 years and the ultimate longevity of this program relies on maintaining a keen focus on the core principles assembled by the SRTP founders a decade ago.

Success of any program is borne from a foundation of common sense, coupled with a targeted energy of the entire team. The SRTP has taken the original team members from Dauphin, Cumberland, Perry, Lancaster, Lebanon and York and strategically expanded the scope of the program into Adams, Franklin and Berks Counties. These counties, representing the south central portion of Pennsylvania, have spearheaded the efforts to decrease traffic congestion and improve air quality for many years. The success generated by this program offers great pride, not only for those in the immediate region, but also for planning and transportation entities across the Commonwealth.

The Transportation Demand Management (TDM) industry has long held that modes of transportation other than the single occupancy vehicle are vital to the development of sustainable communities. In Pennsylvania, we now see new transportation legislation and a growing commitment to the growth and development of multi-modal opportunities. The SRTP looks forward to the common alignment of our core principles of more sustainable transportation modes and the new path of multi-modalism across the state.

As the SRTP looks to the future, the core principles of the Commuter Services of Pennsylvania program will not change. The commitment to educating commuters on all available modes of transportation and actively pursuing new constituencies to implement the usage of carpooling, vanpooling, transit, biking, walking and teleworking remain at the forefront of our efforts. In a similar nature, the Board of Directors for the SRTP will continue to look beyond their current geographic boundaries to search for unserved and underserved localities that may benefit from the implementation of Commuter Services' programming.

While endeavoring to offer a better quality of life for all members of our community, the backbone of our strategic plan continues:

- Pursuing our goals in a fiscally responsible manner
- Working with our partners across the local, state and federal levels of government
- Striving to provide commuters a safer, quicker and less costly ride to work
- Spearheading the efforts to decrease demand on our transportation infrastructure
- Continue to reduce our carbon footprint















# BARTA and RRTA form South Central Transit Authority



In December, the Boards of Directors for the Berks Area Regional Transit Authority (BARTA) and the Red Rose Transit Authority (RRTA) took action to join the transit agencies and operate under unified management.

After the passing of long-time Executive Director Dennis Louwerse in 2013 left a void in the management hierarchy at BARTA, the leadership began talks with RRTA to consider the possible sharing of its Executive Director, David Kilmer. Initially, David Kilmer served as Executive Director at BARTA through a management agreement with RRTA, and the two sides began to discuss the potential for a merger of the two neighboring agencies.

### A number of factors made the merger worth considering:

In addition to their geographic proximity and the common border of Berks and Lancaster Counties, the transit agencies also share individual annual budgets near \$17 million. BARTA has a handful more fixed route buses in their service area, and RRTA maintains a slightly larger fleet of shared vans, however total inventory of vehicles is very comparable.

In April 2014, formal meetings began between the BARTA and RRTA Boards for merging the management components of these transit agencies. Both groups felt a merger would be advantageous in terms of cost savings, and specifically, a management merger would allow each agency to continue to service their community as BARTA and RRTA. A Resolution was drafted that outlined the financial gains to be made by both entities while reassuring the transit service in each community would remain the same.

Through the consolidation of several management positions, and diligent work by the members of the BARTA and RRTA merger committees, the birth of the South Central Transit Authority (SCTA) was finalized in early December 2014. The SCTA will be headed by David Kilmer and the headquarters for the new authority will be at the RRTA offices in Lancaster, Pa.

The immediate cost savings in 2015 is estimated to be \$780,820 by combining the transit agencies. Additionally, the future savings in the next five years has been tallied at \$819,861 in 2016 and grows to an amount of \$996,546 by 2020 for a total five year benefit to taxpayers of \$4.530,250.



# Regional Bike Rack Map Debuts

Commuter Services consistently looks for ways to assist commuters who make the smart choice to get out of a single occupancy vehicle and utilize a mode of transportation such as bicycling, walking, carpooling, vanpooling, transit or teleworking.

This year, Commuter Services launched its new, interactive Regional Bike Rack Map. The electronic map provides bicyclists with information and locations of more than 120 bike racks throughout the Commuter Services nine-county region. Bicyclists can quickly view photos and site descriptions of each rack and then get directions to the rack, making it easier to find parking while they commute through the area. The map is an ongoing project and will continue to grow with more bike rack locations being added during additional phases of the project.

# Vanpool Appreciation Month

By participating in a vanpool, commuters save money on gas, insurance and wear and tear on their personal vehicle. A typical vanpool consists of eight to 15 riders who have a consistent work schedule and ride more than 20 miles one way to work.

Currently, Commuter Services assists 36 vanpools in a nine-county service area. More than 240,000 miles one-way are eliminated each day by these commuters choosing vanpooling as their commute option rather than driving alone.

During Vanpool Appreciation Month, riders were encouraged to share how vanpooling has impacted their daily commute and a winner was selected from among the submissions.

# IN THE COMMUNITY

## Earth Day

In 2014, **336 commuters logged 69,115 miles** by riding transit, carpooling, vanpooling, bicycling, walking or teleworking during the week of Earth Day, April, 20-26.

### Bike To Work Week

A total of **112 participants logged 3,459 miles** while commuting to work by bicycle during the 2014 annual Bike to Work Week Challenge, May 12-16.

## Dump the Pump

The June 19th Dump the Pump Essay Contest encouraged commuters to take a more efficient transportation mode on National Dump the Pump day and to write about it. In 250 words or less, commuters wrote about how much money they have saved and/or how their quality of life has been improved when they "Dumped the Pump" by using a non-single occupancy vehicle commuting option.

# Try Transit Month

Commuter Services of Pennsylvania launched its fourth annual 'Try Transit' month in September 2014, encouraging local commuters to try bus or rail transportation options rather than driving alone. A total of 271 participants, across 16 counties, logged their transit trips. Participants logged a total of 277,656 miles traveled by bus or train instead of their cars during the month of September.





Commuter Services announces the milestone of 25,000 active commuters in the program's database.


