**Commuter Services Announces Winners of Bike Month Challenge**  
Participants Log Record Number of Miles Biked During This Year's Challenge

**York, Pa. (July 12, 2018)** – Commuter Services of Pennsylvania announced the winners of its tenth annual Bike Challenge held in May. Pennsylvania commuters participating in the challenge surpassed previous records and logged 8,427 miles while commuting by bicycle as part of the challenge. One-hundred and one participants made more than 1,800 trips by bicycle during the annual event, which encourages commuters to choose bicycling as a greener and healthier mode of transportation for work and leisure. Last year, 64 commuters logged 7,603 miles.

Three local bicyclists were randomly selected to win a \$25 Tröegs gift card and Commuter Services Bicycle prize pack. The winners were:

- Laura Hatton of Lancaster (30 bicycle trips).
- Brandon Perrone of Berks (ten bicycle trips).
- Levi Schneck of York (two bicycle trips).

PSECU, located in Dauphin County, took first place as the employer with the most participants, earning them a prize of a free breakfast. Seven employees of the credit union logged 82 bicycle trips during the challenge.

The Bike Month Challenge was open to all employers in the participating counties of Adams, Berks, Carbon, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Monroe, Perry, Pike, Schuylkill and York, as well as commuters who live or work in these counties.
